Orange County Assessor Webster J. Guillory has delivered the 2011-12 Local Assessment Roll of Values that includes all locally assessable property in Orange County. The total net taxable value on the Roll is over \$420.3 billion. The Roll of Values is up 0.87% or \$3.61 billion more than last year (2010-11).

The \$420,396,019,090 Local Assessment Roll includes 1.061 million units of property valued on the Secured Roll and the Unsecured Roll. The Secured Roll represents the Proposition 13 increases and decreases in taxable value of all locally assessed real estate, excluding exempt properties such as churches, hospitals and schools. This year the Secured Roll includes 901,840 parcels and has a total value of \$400.4 billion, an increase of \$4.26 billion or 1.08% more than last year. The Unsecured Roll consists of business personal property, plus marine and aircraft assessments. The 2011-12 Unsecured Roll of \$19.98 billion represents a decrease of \$640 million or 3.13% less than last year. The Unsecured Roll has a total of 159,464 assessments, including approximately 124,600 businesses, 33,900 boats and 920 aircraft.

It is important to emphasize that these are property values as of January 1, 2011. Many properties in Orange County continued to show a decline in value during 2010 and some areas had properties that increased in value during 2010. The Assessor conducted a review to look for properties with a taxable value that may be higher than their December/January market value. Approximately 300,000 properties were reviewed, including single-family homes, townhouses, condominiums, multi-family apartments, commercial/industrial buildings and timeshares. Approximately 181,000 of these properties will have their taxable values reduced or kept the same as last year (no increase). Most of these properties sold between January 2002 and December 2010, and these taxpayers should see some reduction or no increase in their property tax bills.

The Assessor reviews for 2008 through 2011 have reduced net taxable value by over \$34 billion countywide. This year, however, there are some areas in the County showing some recovery in market value. About 29,500 properties that had a decrease in prior years will see their taxable values increase, adding back approximately \$1.6 billion. Many of these properties will see increases greater than 5% year to year, and we normally receive some questions about value restoration changes.

The number of commercial, industrial, and multi-family properties receiving value reductions increased from about 7,100 last year to over 8,300 properties this year. The market for these properties continued to decline in 2010. The number of residential properties with value reductions is over 168,000 parcels, compared to almost 156,000 last year. The real estate markets continue to be dynamic.

Overall, the Roll of Values increased by 0.87% after decreases for the last two (2) years (-1.23% and -0.48%). Resales, new construction, rehabilitations, and new development remain at their combined lowest level in twenty (20) years.

Orange County has 34 cities, and every city has some properties that decreased in taxable value. These are properties with a market value that has declined and is less than their Prop. 13 taxable value.

Seal Beach has the highest value increase by percentage (3.62%), followed by Yorba Linda (2.96%) and Westminster (2.32%). Irvine is firmly the county's number one city with the highest total assessed value of \$47.1 billion, an increase of 1.45% over last year. Newport Beach is second with a value of over \$39.1 billion, a 0.93% increase over last year. Anaheim has the county's third highest total assessed value of \$34.7 billion, an increase of 0.88% from last year.

Eight (8) cities out of 34 have a year-to-year decrease in net taxable value. The year-to-year decline in taxable value is also less significant compared with last year; only Laguna Woods has a decline greater than 1% (-1.22%), followed by: Los Alamitos at -0.71%, and San Clemente at -0.59%.

The statewide CPI increase is 0.753% for all properties that have a market value greater than the Prop. 13 taxable value on January 1, 2011. Last year, the CPI was a negative 0.237%.

This year again there has been significant inquiry from homeowners about Prop. 13. Prop. 13 works in more than one way to restrict the taxable value of property. First, the basic tax rate is fixed at one percent (1%) everywhere in California. Second, if the market value of property is higher than the Prop. 13 taxable value, then the taxable value will show a small increase (0.753%) for 2011. Third, sales (transfers) and new construction are valued at market. Fourth, taxable value for each year is the lower value of the market or the Prop. 13 taxable value on January 1.

A property value notice for each property is in the mail to the owners of real estate as of January 1, 2011. If a notice is not received by July 20, owners should contact the Assessor Department at (714) 834-2727 to verify their mailing address or to request a duplicate notice.

Value provided on the notices has been determined in accordance with Prop. 13 and other applicable laws. All taxable property is valued as of January 1, the lien date, as prescribed by law. The Assessor is required to enroll the property's Prop. 13 taxable value or the market value on January 1, whichever is lower.

New construction, changes in ownership and market value changes that occur after January 1 are not included on this July notice. Assessable events that occur after January 1 may be adjusted with a supplemental assessment during the year, and will be included in next year's annual value notice.

The Assessor conducts a proactive program to review value changes in the marketplace to find properties that require a taxable value adjustment. The public participates in this process by sharing useful market data on similar properties in their areas. Some people have started to ask what's going to happen through the end of this year. The Assessor will continue to conduct reviews and may reduce taxable values even further if the market conditions on January 1, 2012, show a greater decline. Taxable value can also be restored (increased) as market value increases. Increases/restorations are applicable only up to the Prop. 13 taxable value limit.

Value notices are mailed to the owner, as of January 1, at the address on file with the Assessor Department. To change a mailing address, please complete and submit the "Change of Address Notice" form on the Assessor website at <http://www.ocgov.com/assessor>, or send a request with the following information immediately: assessor parcel number (APN), property address, new mailing address, owner's name, name of person requesting the change, a daytime telephone number and the effective date of the change. Address change requests should be sent to the Orange County Assessor Department at PO Box 628, Santa Ana, CA 92702-0628.
